Bill 31 - Emergency Management Act

This Bill gives a politician the arbitrary decision making power to declare an "Emergency" - take away your rights to protect your property and the government may take what it wants from you and your family, if you resist you will be punished.



Bill 36 - Health Professionals and Occupations Act

I will hold all elected representatives accountable for the decisions they make and expect them to uphold and protect my inherent sovereign rights and freedoms.




